a. System & Other Requirements

1. The application would work only on PIII with availability of free 512 MB RAM or above.
2. Connectivity with Aruhat Server for access to Wealth Envoy (Internet any other medium).
3. Supported Mozilla compatible Browser and Internet Explorer
4. Active GSM Number for Numerical Sender ID (optional)

b. Service Technical Specification

1. Alphanumeric Sender ID will support up to 8 characters.
2. The Maximum Character Size of SMS is 160.
3. If SMS character size is larger than its regular size, then it will be considered as multiple SMS and it may split in multiple parts.
4. Sender ID requires availability on Gateway and Registration.
5. Sender ID activation requires one business working day.
6. Aruhat reserves all rights to make change, add or remove any feature or functionality, or module in current and/or future system and/or system interfaces and/or services and/or service specifications at any moment of time without prior notification.

c. Ownership

1. The ownership of application is under Aruhat Technologies Pvt. Ltd.
2. Aruhat Technologies Pvt. Ltd. will provide only services to "Customer/User", and there shall be no ownership of "Customer/User" for application, software, hardware used to render the services.

d. Payments

1. Payment term is 100% advance along with "Customer's/User's" confirm order.
2. At Par Cheque/DD should make the payment in favor of 'Aruhat Technologies Pvt. Ltd.' payable at Ahmedabad. Any charges related to payment should be bared additionally by the customer.
3. For Renewal or extension of License, the payment terms is 100% advance along with your confirm order.

3. To increase subscriber licensing, "Customer/User" has to purchase a new License.
4. Valid and Active License is required for interrupted services.
5. "Customer/User" using VIBGYOR SMS credits for Wealth Envoy account, should ensure his/her VIBGYOR account to be active along with SMS credits being available.
6. "Customer/User" using bundled Wealth Envoy account must follow the fair usage policy (contact us for more details about fair usage policy).
7. After expiry of License, Aruhat Technologies Pvt. Ltd. is eligible to remove the Wealth Envoy account of the respective "Customer/User" at any point of time after 30 days of expiry.
